# YOUTUBER PROMOTION AGREEMENT

## **PURPOSE**

The purpose of this Agreement is to collaborate on promoting TheBestCraft (TBN) Minecraft Server through live streaming and content creation.

## **OBLIGATIONS OF THE CONTENT CREATOR**

The Content Creator agrees to:

- Perform at least one (1) live stream per week featuring TheBestCraft (TBN) Minecraft Server.
- Promote the server in a positive and engaging manner.
- Include the server IP and relevant links in video descriptions or stream titles where applicable.
- Maintain professional conduct while representing the server.

## **NON-EXCLUSIVITY**

- The Content Creator is allowed to create content and stream on other Minecraft servers or platforms.
- This Agreement does not restrict work with other servers or brands.

## **COMPENSATION**

- Initially, no guaranteed fixed payment is provided.
- Once the server begins generating net profit, the Content Creator will receive:
  - 10% to 20% of the server's net profit,
  - The exact percentage will be agreed upon based on performance, contribution, and mutual discussion.

## **TERM AND DURATION**

- This Agreement shall remain valid for a period of one (1) year from the start date.
- It may be renewed upon mutual agreement.

## **TERMINATION**

Either party may terminate this Agreement under the following conditions:

- With 14 days written notice, or
- Immediately in case of:
  - Breach of agreement terms
  - Misconduct or damage to reputation

## **CONTENT RIGHTS**

- The Content Creator retains full ownership of their content.
- The Server Owner may share or repost content with proper credit.

## **CONFIDENTIALITY**

Both parties agree not to disclose confidential server information, strategies, or financial details without consent.

## **GENERAL TERMS**

- This Agreement does not create employment; it is a collaboration/partnership.
- Any changes must be agreed upon in writing by both parties.
